*Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation and employer of individuals whose contribution exceeds \$200 in a calendar year. Federal contributions must be made from the contributor's own funds and cannot be received from corporations, federal contractors, labor organizations or foreign nationals. State law requires that we collect physical address, occupation and employer information for individuals whose contribution exceeds \$100 or more. These contributions are not tax deductible as charitable donations on either state or federal tax returns.*

All individual (non-corporate) contributions will be allocated to the Federal PAC unless otherwise designated by the contributor. (up to \$5,000 per calendar year.)

Federal election law prohibits corporate contributions including sub-S corporations, to a Federal PAC. Personal checks (up to \$5,000 per calendar year) are preferred for federal contributions. Personal checks from joint accounts may complete the form below to allocate % of contribution per individual. Contributions that do not specify, will be designated 100% to the signer of the check unless otherwise noted.

Some LLC's and partnership contributions may be allowable to the Federal PAC if the LLC pays taxes as a sole proprietor or partnership and is not listed as an S-Corp. *Partnership contributions are permissible up to \$5,000 per calendar year.* A contribution from a partnership counts proportionately against each participating partner's own limit. (please complete the form below to allocate partnership ownership)

State contributions are allowable from any source (individual, partnership, corporation) in any amount. However, only \$8,100 per person, per calendar year may be used to directly support state candidates. Any amount over \$8,100 may be used for local candidates, ballot measures, independent expenditures, and administrative expenses.
